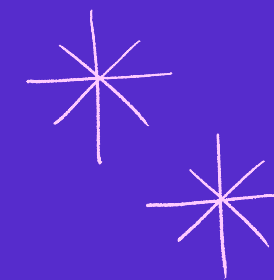

Benefits of passeport talent residence permit



Long validity period:

The "Passeport Talent" is issued for up to 4 years, with the possibility of renewal, exceeding the standard one-year residence permits.

Right to work:

Holders of the "Passeport Talent" can legally work in France without the need for an additional work permit.

Family reunification:

The spouse and minor children of the applicant are eligible for a multi-year residence permit, allowing them to work and study in France.

Benefits of passeport talent residence permit



Freedom of movement:

Holders of the "Passeport Talent" can travel freely within the Schengen Area without requiring additional visas.

Access to social services:

Residents have access to the French healthcare system and other social services on par with French citizens.

Pathway to citizenship:

After 5 years of residence in France with the "Passeport Talent," there is an opportunity to apply for French citizenship.

Eligibility Criteria:



✔ Financial Investment:

Commit to investing at least €30,000 in the proposed business venture.

✔ Experience:

Hold at least a master's degree or have a minimum of five years of professional experience at a comparable level.

✔ Sufficient Resources

financial means equivalent to the French minimum wage (SMIC), which is €21,621.60 as of November 1, 2024.

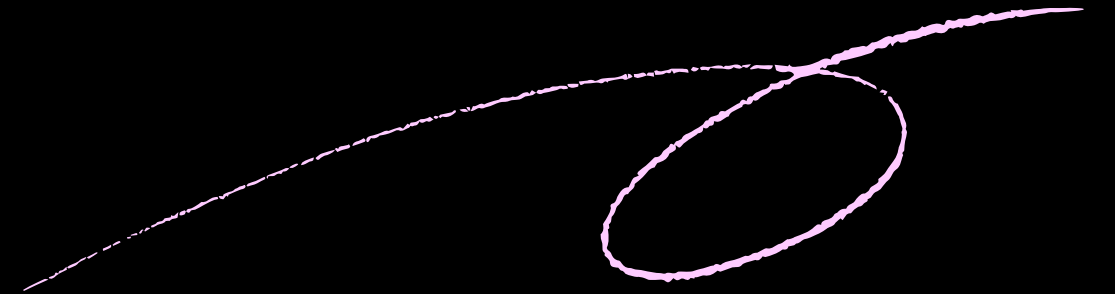

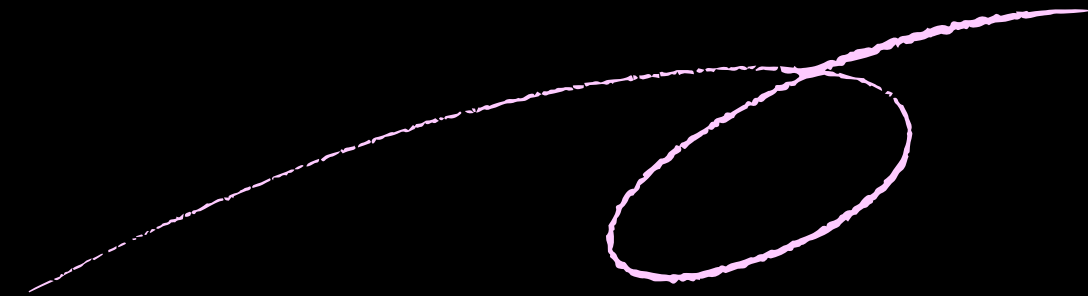

- Certificate of No Criminal Record: With apostille
- Financial Deposit: €30,000 for escrow account
- Bank Statement: Showing a balance exceeding €21,500
- Curriculum Vitae (CV)

Estimated Additional Costs:

Duration of residence permit

The Passeport Talent – Création d'Entreprise residence permit is most often issued for four years. However, depending on the specifics of the application and the discretion of the issuing authorities, it can also be granted for three years, two years, or in some cases, one year.

Conditions for renewal of residence permit

The activity must generate income equivalent to at least the French minimum wage (SMIC), which is currently €21,500 per year.

Language skills

Whether there is a work permit

The Passeport Talent – Création d'Entreprise residence permit authorizes you to establish and manage a business in France. However, it does not grant the right to engage in salaried employment for another employer.

Requirements for residency

While there is no explicit legal requirement to reside in France for more than six months annually, maintaining a significant physical presence is recommended.

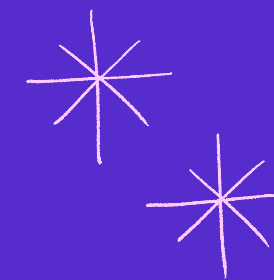

Requirements for residency

Permanent Residency: Eligible after 5 years of continuous residence in France, provided you meet the necessary conditions, including demonstrating proficiency in French at a B1 level (intermediate level). **Citizenship:** You may apply for French citizenship after 5 years of residence if all requirements are fulfilled, including proficiency in French at a B2 level (upper-intermediate level).

Advantages of obtaining a D visitor visa in France:

Extended Stay:

Allows for long-term residence in France, typically up to one year, with the possibility of renewal.

Residency rights:

Provides legal residency status in France, equivalent to a residence permit.



Access to french healthcare:

Enables enrollment in the French healthcare system (upon meeting the eligibility criteria)..

Advantages of obtaining a D visitor visa in France:



Family reunion:

Ideal for accompanying family members of residents or students in France, ensuring they can legally reside together.

Simplified renewal process:

Easier to renew compared to applying for a new visa, provided all requirements are met.

Freedom of movement:

Facilitates travel within the Schengen Area without the need for additional visas.

Eligibility Criteria:



- ✔ Purpose of stay: the primary intent should be to reside in France for personal reasons (e.g., extended visits, retirement) without engaging in any professional or commercial activities.
- ✔ Demonstrate sufficient financial resources to support your stay, exceeding the French minimum wage (SMIC - 21.500 euros). This can be provided through personal funds or financial support from a sponsor.
- ✔ Accommodation: provide proof of accommodation in France, such as a rental agreement, property deed, or an attestation from a host.
- ✔ Health insurance: obtain comprehensive health insurance valid in France for the duration of your stay.



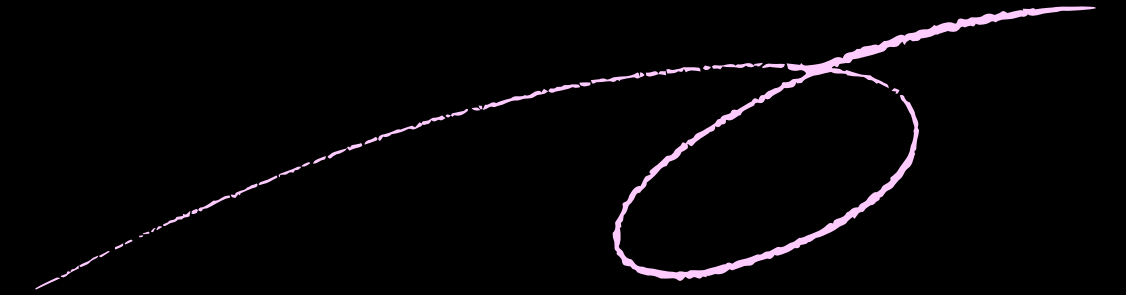

Documents to be provided by the Client

- Valid passport: a passport valid for at least three months beyond the planned stay, with at least two blank pages.
 - Bank statements: proof of sufficient financial resources.
 - Documents explaining socio-economic situation: such as diplomas, work contracts, certificates of incorporation (if you own a company), etc.
 - Marriage certificate: if married.
 - Children's birth certificates: for dependent children, if applicable.

Estimated Additional Costs:



- Apartment Rental: €2,500 to €8,000 (includes agency commission, first month's rent, and security deposit).

- Visa Fees and Duties: €350.

Sufficient financial resources: provide evidence of adequate financial means to support your stay without employment. This typically involves bank statements or proof of income demonstrating financial independence.

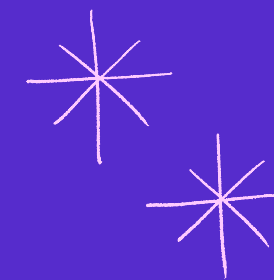

Possession of a relevant bachelor's degree or its equivalent.

✔ Language Proficiency:

proficiency in French or English at B2 level.



Documents to be provided by the Client

- High school diploma or university degree
 - Academic transcripts
 - Passport with sufficient validity period
 - Language certificates (if available)
 - Description of previous work experience and educational background
 - Letters of recommendation (if available)
 - Proof of sufficient financial resources for living expenses in France, starting from €615 per month (a recommended amount is €1,500 per month or more).
 - Sponsors, such as parents, may provide financial support, accompanied by a sponsorship letter and supporting documents (e.g., bank statements).

Estimated Additional Costs:

- Apartment Rental in France: from 600 euros/month
- Student and Campus Life Contribution (CVEC): - a mandatory fee of €100 per year for all students enrolling in French higher education institutions.
- Monthly transportation passes range from €30 to €80, depending on the region.
- Academic materials may cost €200–€300 per year, depending on the program.
- The cost of a student visa is approximately €50–€99.
- Food, utilities, and other personal expenses average €200–€400 per month.
- Private institutions or specialized programs may charge tuition fees ranging from €3,000 to €30,000 per year, depending on the field of study.
- Leisure, clothing, and other non-essential expenses may vary based on individual lifestyle.

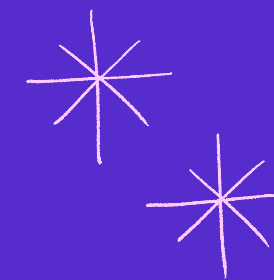

In the first year of their stay in France, nationals of certain countries are entitled to exchange their driving licence for a French driving licence.

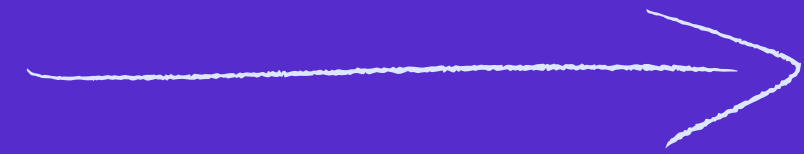
